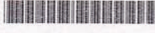

4) **OBJECT OF THE TRUST :**

- 1) To promote quality Education Nursery , schools, colleges, and other Institutions etc.
- 2) To provide for the well-being , maintenance, necessities of life and general welfare of the beneficiary.
- 3) To provide the beneficiate with assets from time to time in furtherance of their general well-being and welfare ; and
- 4) To achieve the aforesaid objects, the trustees shall administer the Trust property in such manner as in their discretion may deem fit and proper , as to generate adequate income . The Trustee/s shall in the first instance , collect all the income of the Trust , and determine the not profit or loss after providing for all expenses incurred in the realization , satisfaction of the income, as also for the management and administration of the trust property , either annually or at such intervals of the Trustees/s may feel convenient . The net profit or loss so determined shall be divided and credited to the account of the beneficiary either directly or in his account or on their behalf and such payments shall be to the account of the beneficiate by the Trustee in the book of the Trust.

5) **CAPITAL FUND OR THE CORPUS OF THE TRUST:**

The Author of the Trust both hereby declare the schedule property ,either with and subject to all her liabilities in correct through the trust property and that the Board of Trustees shall hereafter own , hold and be stand possessed of the same upon Trust together with income, additions and accretion thereof the absolute benefits of the aforesaid beneficiary till be determined of the trust . #### 6) TRUST FUND OR TRUST PROPERTY

The trust and or Trust property shall mean shall mean and include not only the corpus of the trust , but also all the income arising from the same which is distributed to the beneficiary except the Honorary members in the accounts of the trust as also those remaining unpaid to him , and also all the investments of the trust as also time being representing the same time being representing the same . The present contribution of the trust members is fixed as Rs.5000/-also include all other monies which come into the ownership ,possession and control of the trustee/s or on account of the Trustees and or its possession building funds and other Trust Development funds can be raised by any voluntary donors and also from Government , Non - Government and Foreign Agencies fund which is reserved for Education purpose.

#### 7) BOARD OF TRUST :

Any vacancy arising in the board of trustees by reasons of death or resignation or disqualification of trustee, the other trustee shall have an absolute right to nominate any person as a Trustee of the board of trustees to fill up the vacancy. Any new person can be nominated as Trustee with the sole permission of all the above trustees . Newly nominated trustee shall have all rights like other Trustees . If the vacancy is not filled up, the sole remaining Trustees alone can constitutes the board of trustees to exercise the powers under this deed of Trust.

#### 8) POWER AND DUTIES OF THE TRUSTEES/S

The Honorary member are not entitled to any benefit either in profit and loss. The trustees/s shall be vested with all the power as are necessary for effective conduct and management of the Trust and administration of Trust property , without prejudice to the generally of the foregoing , the Trustees shall have the following powers in the course of administration of the Trust property and fulfilling the objects of the Trust and such power and duties shall be exercised by Board , through the managing trustee:

**1) To create fund required from the management of Trust.**

- i) To open one more bank account in the name of the Trust and operate the same . The Chairman of the Trust will operate the bank account of the trust and also their is a provision change power of operating trust bank account for any other trustee/s with opinion of all the trustees.
- ii) To invest the funds of trust in such property investments , business shares, etc., as the trustee/s in office may deem expedient . The trustees shall be titled to make investments at the trustee/s absolute discretion and the provisions of section 20 of the Indian Trust Act 1982 , shall not apply to this Trust . Further the trustee /s shall be empowered to sell or vary any investment or any investment or any in interest therein as the trustees may from time to time determine.
- iii) To purchase or otherwise acquire immovable properties, free hold or lease hold and to convey the same into account and to construct building and commercial structures there upon and sell or let out the same on rent, on monthly or yearly basis , as may be considered expedient by the Trustee/s in office.
- iv) To lend advance and invest the funds of the trust at trust at such rate of interest as may be considered reasonable.
- v) To borrow monies for and on behalf of the trust and to execute necessary documents for such borrowals.
- vi) To sell, mortgage , hypothecate or create al lien or charge and otherwise alienate all or any of the properties of the trust.
- vii) To receive voluntary contributions from any persons whatsoever by way of donation , legacy and gifts and to hold the same upon trust for the benefit of the beneficiate subjects to the powers, provisions and stipulations setout herein.

- ix) To Institute suits and other proceeding and to represents the trust in all courts of law , Income Tax authorities and other statutory authorities and to verifying , pleading and written statements and appoint of advocates , Chartered Accountants to represent the treat in all forums.
- x) To appoint one or more persons as Co- Trustee/s.
- xi) To settle compromises or compound all or any debts , claims , outstanding , accounts, disputes , demands, actions, suits and proceeding whatsoever , by or against or relating to the trust or for the same to arbitration.
- xii) To appoint any person as power of attorney holder for the management of the Trust property and to achieve the objectives of the Trust . The Trustees shall in no way be diverted of their office by the delegation of any power to any attorney and such delegation shall only be expeditious and efficient administration the trustees shall have the right to revoke any power delegated to any attorney.
- xiii) To, raise contains or accept gifts or contributions in cash kind from any person for the purpose of the Trust and hold the same under the same terms and conditions contained in the presents, and the amount so received by way of donation or contribution shall not be treated as the income of the Trust , but shall be credited to the capital fund of the trust.
- xiv) To make rules and regulations for the purpose of management of the trust and its affairs and vary or modify any of rules so made .
- xv) To make payments to beneficiates from out of the monies stand and to their credit out of the income credited to their account annually subject to availability of the funds.
- xvi) The Trustee/s shall not have power to invest the funds of the trust in any business which is of a speculative nature or in the nature or gambling.
- xvii) The managing trustee or any person to whom the power of the trustee are delegated shall have the right to reimburse or to pay from out of the Trust Funds all the expense which may be incurred by him them in the trust and in execution of the objects of the trust.
